

Irregular Collection Services

Shellharbour City Council offers an on-call Irregular Collection Service that may assist during periods when your recycling, organics or waste exceeds your usual amount, e.g. festive season or events.

This collection fee is to be paid in advance by credit card over the phone or in person at the Council Administration Centre customer service desk.

Bulk Kerbside Collection

Shellharbour City Council offers an on-call Bulk Kerbside Collection. This service allows residents to place up to 2m³ (or 200kg) of unwanted household items for collection from the kerbside (conditions & fees apply). Please note the following instructions and rules apply when using the Dunmore Recycling & Waste Disposal Depot:

- All items to be disposed of at the designated areas as directed by staff.
- All vehicles are to reverse up to the Transfer Station wall and stop at the wheel stops. Do not drive over the wheel stops.
- Do not climb the wall or enter the Transfer Station Pit. If you require any assistance, please signal the Transfer Station Supervisor.
- Children and animals are to remain in the vehicle at all times.
- Enclosed footwear must be worn.
- No smoking.

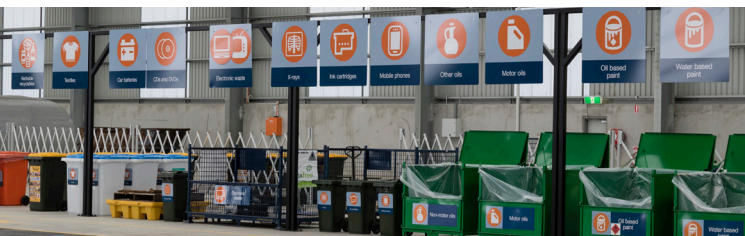

Waste Management Fees & Charges 2019 - 2020



DUNMORE RECYCLING & WASTE DISPOSAL DEPOT



Shellharbour City Council provides a facility for recycling, recovery, reuse and disposal. The fees and charges for disposal are designed to minimise waste to landfill and encourage materials separation and resource recovery. The more you sort your waste and separate recyclables, the more you will save on landfill disposal costs and help the environment by:

- Saving precious resources from landfill
- Reducing greenhouse gas emissions
- Conserving natural resources
- Managing consumption

Charges are per tonne, unless a minimum charge or other charges are specified. Waste to landfill charges includes the NSW Waste and Environment Levy of \$143.60 per tonne (ex. GST). This component of your fee is paid directly to the NSW State Government.

Revolve Centre



On entering the Dunmore Recycling & Waste Disposal Depot, you will find the Revolve Centre on the right. The Revolve Centre is a modern drop-off recovery, recycling and reuse centre.

Here you can offer your unwanted saleable second hand items prior to reaching the Transfer Station weighbridge.

Domestic Kerbside Collection Services

Residents are provided with a three bin kerbside collection service.*

Weekly collection of 140L FOGO bin, fortnightly collection of 140L recycling bin and 140L waste bin	\$420 per annum
Weekly collection of 240L FOGO bin, fortnightly collection of 240L recycling bin and 140L waste bin	\$425 per annum
Weekly collection of 240L FOGO bin, fortnightly collection of 240L recycling bin and 240L waste bin	\$555 per annum

Council also offers a Waste Collection Service on compassionate grounds. These collections are reserved for special needs households who, by nature of a verified, permanent or long-term medical condition, generate excessive quantities of non-recyclable waste that cannot be managed using the standard collection service.

Additional waste bin (140 litre)	\$145 per annum

Additional recycling bin	\$75 per annum

These charges cover the collection, processing and disposal of material collected in your kerbside bins. It also includes the NSW Waste and Environment Levy (\$143.60 per tonne ex. GST), that is applied to every tonne of waste sent to landfill.
